ARTS & CRAFTS VENDOR SECOND STREET PROMENADE APPLICATION

The First Saturdays Art Walk event is held every first Saturday of the month from 7 to 10pm in Downtown Santa Ana. By filling out this application you may be eligible to participate as a vendor at the Second Street Promenade on the night of the event. The Second Street Promenade is located at Second Street between Broadway and Sycamore Streets.

FREQUENTLY ASKED QUESTIONS

Criteria: Vendors are selected based upon the quality of their products & booth presentation. --- All products must be made by you --- These can include: original paintings, drawings, photography, digital art, sculpture, ceramics, works in glass, wood, metal and other natural or recycled materials. Please note that some spaces are reserved for vintage and clothing brands but the majority of spaces are for arts & crafts only. Priority is given to Santa Ana & Orange County residents.

Spaces: All approved vendors will have a 10'x10' space which will be assigned on the week of the event. You will need to bring your own tent, table(s), chair(s), light(s), extension cord(s), and tape to cover all visible cords. Electricity will be available.

Costs: \$45 (or \$25 with a valid Santa Ana Business License number) **Approval:** Applicants will be confirmed by email or phone at least one week before the event date. **Payment:** Your payment will be due once you have been approved. You may pay by cash or check: payable to Downtown Incorporated.

Setup: Setup time is between 4:30pm and 6pm. Load-in at Sycamore Street between First & Third Streets.

Breakdown: You may begin breaking down after 10pm.
